#### **JUROR**

Karen Cohen is an award winning photographer with over 50 years of experience in the photographic world. She attended Germain School of Photography in NYC after high school and completed the Professional Photographer two year certification course. journals and cover photographs.

Having been a member of art leagues in Charlotte and Washington DC, Cohen has had numerous solo shows and has won various awards. She is a member of Women's Caucus for Arts, Capitol Hill Art League, and was chairperson and juror for Capitol Hill Art League for many years. Her work has been featured in Charlotte Taste Magazine and is featured in gallery exhibits at Tamarack Best of West Virginia where she also serves as a juror for new artists, as well as The Beckley Art Center, WV and Capitol Hill Arts Workshop in DC.

#### **ELIGIBILITY**

Open to U.S. residents, 18 years or older. Photographs must be original photographs or photographically derived work, and not done under supervision. All work submitted must be suitably prepared for installation. The curator reserves the right to deny entry if any work is deemed not suitable for display or too difficult to install. Entries must have been completed after January 1, 2016, and not previously exhibited in a Lynchburg juried photography show,

# **ENTRY FEE**

Entry fees are used to offset necessary expenses involved in making the show possible. A non-refundable fee of \$35 entitles each artist to submit up to three entries. Make check payable to the Academy Center of the Arts.

#### **ENTRY PROCEDURES**

The competition will be juried from emailed digital images. One image per work is permitted. Digital images emailed must be in jpeg format, 300 DPI, minimum size of 4"x6". All images along with entry form and entry fee must be postmarked by June 20, 2022. Please email your images to: tbatt@academycenter.org.

#### JUDGING

All entries will be juried by digital images or slides. If, upon delivery, an accepted work is found to have been misrepresented by the digital image, it may be disqualified. Award winners will be selected by the juror after the exhibition is installed.

#### **CASH AWARDS**

Cash awards will be given at the discretion of the juror. "Best in Show" Cash Award is \$1000. Cash Awards sponsored by Select Bank.

#### CATALOGUE

A full color, soft bound catalogue of the exhibition will be produced and offered for sale during the exhibition.

#### **PURCHASES**

All of the works are available for purchase unless designated "Not for Sale" at the time of entry. The Academy Center of the Arts will facilitate sales and charges a 35% commission. Works not for sale must have a value for insurance purposes. In this case, determine a potential sale price and enter 60% of that dollar value.

#### **DELIVERY OF ACCEPTED WORK**

Entries may be shipped or hand-delivered to the Academy Center of the Arts, 600 Main St., Lynchburg, VA. 24504. Shipped entries must be sent in reusable containers (no packing peanuts) with funds for return shipping fees enclosed. Hand delivered work will be received on August 22 or August 26 from 9 am to 5 pm. Shipped entries must be received between August 22 - 26, 2022. Accepted work will be insured for the duration of the exhibit if the artist has declared an insurance value.

#### LIABILITY

Accepted works are insured by the Academy Center of the Arts, August 22 to October 5, 2022.

Note: All work must remain on display for the entire exhibition.

Entry in the exhibition constitutes agreement to the conditions set forth in this prospectus.
